#### How many people with Ds in Italy?

- 309.000 people with "intellectual" disabilities (National Statistics Institute)
- 1 child with DS every 1200 births
- 38.000 people with DS
- 25.000 are over eighteen
- Life expectancy: 62 years old



#### **AIPD**

- Year of establishment: 1979, (official government recognition in 1983)
- Legal status: non-profit organisation
- Staff at national level: 18 professionals (social workers, educators and psychologists): 7 full-time and 11 part-time
- Main funding sources: membership fees, donations, financial support from the state. Some grants coming from projects financed by Italian Government and European Commission

#### Mission:

- supporting people with DS and their families
- promoting studies on DS and disseminating information
- supporting school mainstreaming, vocational training and job inclusion, independent living








#### Target group

AIPD supports all the people with Ds, members or not members of the association, of all ages










#### Target group
